## 2016 Biomass Sales

Over the past few months, BGI has noticed a significant increase in demand for our versatile Kostrzewa boilers, as an affordable back-up boiler option. Heating requirements vary from day to day, hour by hour and the UK climate can quickly change from freezing outside temperatures to those where heating would not be needed at all—this is where cascade systems are an ideal solution.



A correctly sized biomass boiler installation should heat the commercial or domestic requirements with a design temperature below freezing, however for at least 80% of our heating periods, the ambient temperature is far higher. By cascading several boilers together, only the energy required at the relevant time is provided.

### **The Advantages of a Cascade Boiler Solution:**

- Larger output range (130kW Biokompakt with 100kW Kostrzewa Maxi Bio provides an affordable option for 230kW)
- High operational safety and redundancy
- Demand orientated heat flow, especially in case of fluctuating energy demand
- Simple and precise power control
- Exceptionally economical operation and efficiency
- Boiler maintenance without heating interruption

## What Major Challenge Does The Industry Face?

According to Peter Solly of Forest Fuels, there needs to be clarity over the Renewable Heat Incentive (RHI), specifically over its funding levels post March 2017.

RHI is confirmed until 2021 as is the total budget, however there is a consultation out at the moment about the exact details over what the potential funding rates will be.

There are several questions to ask, firstly how will this payment rate impact biomass versus other technologies? Even within biomass, what is the detail of how that payment is going to be apportioned within the different boiler sizes? Some food for thought.....
